

Modbury Hospital Foundation Grants Program 2010

Criteria

Eligible applications must meet the mission of the Modbury Hospital Foundation.

Funds will be allocated solely to applicants for research undertaken in Modbury Hospital or Hospital community

Applications must be received in one of the following categories:

- Basic science
- Clinical studies
- Community-based studies

Consideration is also given to 'early career' applicants, applying for the first time as a Chief Investigator, in one of the above categories.

Grant applications must be undertaken via the Foundation's website www.mhfoundation.org.au

As your application will be scrutinised by both academic scientists specialising in various fields of medical research, as well as lay board members, it is in your interest to keep your application concise and apply a style that is as easy to read as is possible, notwithstanding the complexity of the research programme being described.

In order to qualify for further grants, successful applicants from previous years are requested to forward a short, one page appraisal of their research progress, demonstrating the benefit of the grant to their research.

Applicants are asked not to submit more than one application per year.

One original copy and Five Copies of the Application form, together with any supplementary information, including required signatures, must be posted or delivered to the Executive Director of Modbury Hospital Foundation by the closing date.

Late or incomplete applications cannot be considered.

General Research Grant up to \$25,000 per annum

These grants are intended to fund initial or exploratory research, or as bridging or as supplementary support for externally funded research.

Small grants may be awarded to cover the purchase of minor equipment or as a contribution towards the purchase of major equipment providing there is an associated research application.

These grants are open to individuals, units or departments of Modbury Hospital.

Grants may be used to support clinically relevant research in collaboration with any of the three South Australian Universities.

In 2010 there will be only ONE General Research Grant funded.

If you have any outstanding reports or funds to be returned on a previous grant, these must be finalised prior to making an application for the current funding round. Failure to do so may make you ineligible for future funding.
